## **Invitation to the International Table Tennis Tournament – 10th to 11th May 2024 Poland, Otwock.**

Dear Sir or Madam,

Tax & Customs Academy would like to inform you that as a member of the European Customs Sports Association (ECSA), will organize the International Table Tennis Tournament. The tournament will take place at the Training Center of Tax & Customs Academy in Otwock from the 10<sup>th</sup> till 11<sup>th</sup> of May 2024.

As a rule three competitors (1 woman & 2 men) of each ECSA state-member and representatives of DG TAXUD are invited to participate in this event. There is also a possibility to register different number of competitors. The tournament will be organized in six categories: women's singles, men's singles, men's doubles, mixes, women's 50+ and men's 50+. Number of points scored in singles, doubles and mixes will create the ranking of the participating countries.

The participation cost is 190 EUR per participant and includes: registration fee, transportation from/ to the Chopin and Modlin Warsaw airports, accommodation (3 nights in a twin bedroom) and board (Thursday – dinner, Friday and Saturday – full board, Sunday – breakfast).

Arrival of the teams is possible on Thursday the 9<sup>th</sup> of May 2024 in the afternoon hours. Departure of the delegations is expected on Sunday the 12<sup>th</sup> of May 2024 after breakfast.

Participants are kindly asked to send registration forms and make the payment by the 12<sup>th</sup> of April 2024. There will be no possibility to pay in cash at the Training Center.
